In accordance with federal regulations and the Commission *Policy on Monitoring Institutional Performance*, ACCJC applies a set of annual monitoring and evaluation approaches to assess member institutions' strengths, stability, and ongoing alignment with the Standards during the course of the accreditation review cycle The Annual Report (AR) is one of the tools used for this process. Using institutions' self-reported data, the ACCJC Annual Report collects headcount information to monitor institutional growth (including growth in distance and correspondence education) and institution-set standards for key indicators of student achievement, licensure exam pass rates, and job placement rates.

Mt. San Jacinto College demonstrates commitment to continual improvement and innovation through public access to real-time student achievement data, supporting ACCJC Standards and transparency guidelines. While the website includes a dedicated Institutional Research page, clearer homepage navigation is needed. Data is meaningfully disaggregated in alignment with the college's mission, enhancing insight into equitable student outcomes. However, the absence of narrative reflection may limit broader contextualized understanding. These insights inform MSJC's ongoing efforts to enhance data visibility and promote equitable student achievement. Meaningful data storytelling will be the area of focus to further align with ACCJC expectations.

Mt. San Jacinto College typically determines job placement rates using data from the California Community Colleges Chancellor's Office Cal-PASS Plus LaunchBoard. However, the Chancellor's Office has recently transitioned to a new data platform, DataVista. At the time this report was completed, DataVista did not yet provide datasets for the 2023–2024 academic year. Therefore, many of the fields for Question 19 have a rate of 0% reflecting the lack of available data.

To ensure continued transparency in reporting job placement rates when updated data from prescribed platforms is unavailable, Mt. San Jacinto College will explore conducting regular surveys of program graduates to collect self-reported employment information. These surveys will be designed to capture accurate and comprehensive data. All data sources and methodologies used to determine job placement rates—particularly when relying on alternatives to standard platforms such as LaunchBoard or DataVista—will be clearly documented in future reporting cycles.

In this Annual Report, ACCJC seeks to gain additional insights from our member institutions. Regarding student achievement data, these questions seek to learn more about how colleges are advancing student achievement, challenges faced, and support needed.

A key contributor to our institution's recent student achievement gains has been our targeted investment in faculty training for distance education. With over 70% of students enrolled in at least one degree-applicable online course, we prioritized alignment with Regular Substantive Interaction (RSI) requirements to foster engaging, high-quality instruction. Through structured training, peer support, and continuous professional development, faculty have strengthened their online teaching competencies, directly supporting student success and retention.

Additionally, our commitment to data-driven decision making and strategic enrollment management has enabled us to respond effectively to a consistent annual enrollment increase of over 10%. By leveraging enrollment trends and student progress data, we've optimized course scheduling to ensure timely access to high-demand classes. This intentional approach has helped remove barriers to completion and support students in achieving their educational goals. Together, these innovations reflect our institution's student-centered, equity-minded commitment to access and success.

To support our student success goals, we would value Commission-led professional development focused on the Reflection and Storytelling component of the ACCJC Rubric for Effective Institutional Outcome Transparency. While we publish disaggregated, contextualized data, we seek guidance on how to meaningfully narrate that data to reflect institutional efforts toward equitable student achievement. Training on best practices for crafting accessible, equity-minded stories—along with practical examples and strategies for stakeholder engagement—would strengthen our ability to communicate progress, challenges, and next steps. This support would enhance transparency and reinforce a culture of continuous improvement.
