- 3. An appeal may not be submitted until the student receives notification of loss of Promise Grant eligibility and his/her registration appointment has been assigned. This form is NOT use for SAP Appeals.

- 5. After review by the Appeals Committee, if approved, the student's record will be updated to reflect the changes and the student will be informed of the outcome via email. If denied, the student will be contacted. Appeal outcomes are final.
